Date: 01/03/2024

No public comment was offered.

Votes for chair and vice chair split 4 - 3, with White selected chair, and Ahrens

The nomination of White for chair was made by Koontz, seconded by Gutowski.

White received 4 votes: Koontz, Gutowski, Ahrens and White.

Ahrens was nominated by Koontz for vice-chair, seconded by Gutowski. Mapes was nominated by Laughbaum for vice-chair, seconded by Ginop.

Ahrens received 4 votes: Koontz, Gutowski, Ahrens and White.

Committee members will remain the same, with one change to Zoning Board of

Appeals - Ahrens replacing Laughbaum.

Notes: Transportation: Laughbaum brought up the \$450K in ARPA funds that had

previously been earmarked for public transit. He felt the money had languished long enough and should be distributed elsewhere now that there were "four Republicans" on the Board. His suggestion was to take those funds and an additional \$550K of ARPA money (which would come from the \$1M earmarked

commented that the previous transit effort was unsuccessful. Koontz pointed out

for housing) and use that for road repairs in the County. Ginop agreed and

that that would not be an equitable use of the funds as not every district would benefit from the money. In further discussion, it was decided to table the request to allow time for further discussion and consideration.

Emmet County submitted a letter of intent to apply to MSHDA (Michigan State Housing and Development Authority) for funds from a CHILL grant (CDBG Housing Improving Local Livability) which provides financial assistance to homeowners for home improvement projects (insulation, roof repair, windows, plumbing, etc.) In order for Emmet County to apply, a public hearing is required to be set and completed before the application can be uploaded. Per the guidelines of the grant, it states – "Provide for a minimum of two public hearings for the purpose of obtaining residents' views and responding to proposals and questions. The first public hearing must be held prior to application submission to MSHDA and the second near the end of the grant term. The application deadline is February 12th, 2024. I believe this meeting satisfied the requirement for the 1st public meeting.

Public Schools of Petoskey

It sounds like Alcona would like to establish such a clinic and get state funding. My impression at the special board meeting was that the board was not enthusiastic, but that was not apparent

from questions asked after this presentation.

available to the audience. One agenda item was removed at the meeting's beginning due to information being unavailable (training on new email accounts) This November, the PDL's 4-year millage renewal will be on the ballot. The library

will have a float in the 4th of July parade. Friends of the Petoskey Library

reported a cabin fever book sale on March 7th-9th. Construction on the building will be complete in the next few weeks. Treasurer reports a healthy year-end balance carry over to 2024. Nearly all the library usage areas are back to precovid levels. A new policy restricting all solicitation and petitioning on library property was proposed, voted on and passed. The library provides Notary

services.
