Emmet County Commission

Date: 05/08/2023

Notes: A broad range of people attended, and many spoke regarding the issue of the

Board of Health being unable to hold its meeting and conduct business because some of its members did not approve the agenda. Many people felt it was

disrespectful to the people that the members represent.

One commissioner, Neal Ahrens, was recognized for completing the County Commissioner Academy program. It involved 20 hours of training, and it would benefit all the commissioners to increase their knowledge of their responsibilities

by completing the training.
