Date: Notes:	Board of Health 11/07/2023 Commissioners were mostly respectful, but Commissioner Rubingh got very forceful in insisting that COVID cannot be prevented, and that wastewater testing was a waste of taxpayer money. This had been discussed and approved in the budget meeting in September, but he wanted it revisited. After discussion and a motion to immediately stop funding for this, the motion failed in a 4-4 tie vote
Issues To watch:	General public health prevention of disease (wastewater testing discussion) The discussion about defunding the wastewater testing was based on whether or not it was actually preventing any illness; it was Commissioner Rubingh's strong opinion that it was not and could not do so. There were very few public comments. Chairman Hankins spoke at the very beginning to say that he will continue to open meetings with prayer, that "a number of commissioners want to start with prayer, and he is not sacrificing their right to pray" and that no one is required or forced to pray with them. He said he has had a lot of phone calls on the topic. During public comment Rev. Donahoe read a Native American prayer. Another speaker spoke in favor of prayer, During Commissioner Comments at the end of the meeting, Commissioner Ahrens shared the Masonic admonition to not speak of religion or politics within the lodge because these divide people. Eliminating divisiveness is important and this is not a church. Need to respect people. Commissioners Mason and Turnbull both spoke in favor of prayer.
